

Dear Ones,

Our Advent Devotional from the Still Speaking Writers Group makes an excellent point: Darkness gets bad press. I guess the reason why we think so badly of darkness makes some sense. Many of us have a primal fear of the dark, mainly because we do not know what is in it. We are afraid of what we cannot know. But that fear might be preventing us from recognizing or seeing God in the darkness. Maybe we should give darkness a second chance. Did you know, for example, that when the Israelites were wandering the dessert after they had escaped from slavery in Egypt, they were instructed to make a tabernacle, or a largish tent. The center portion of the tent was blocked off from all the other sections and it was called The Holy of Holies, because God dwelled there (Exodus 26). Outside of the Holy of Holies, the priests kept lamps burning all the time. But inside, where God dwelled, it was entirely dark. God chose to dwell in darkness.

I like to think of the symbolism of God dwelling in darkness. Maybe it means that God is most often found when we feel that our world or our lives are "dark." It is exactly at those moments when God shows up or when we can most feel God's presence. It might mean that. Or maybe it means that God dwells in the unknowable or that God IS, ultimately, unknowable. It might mean that, too. But I like to think that it means that there is no place that isn't holy; there is no place where God is not.

If we start to think of God as dwelling in darkness, we might start to rethink what darkness is and what it means. Before his birth, Jesus waited quietly, protected in the dark of His mother's womb—the darkness, not a place of fear or evil, but a place of safety and burgeoning life. So when the days get shorter, greyer and darker, maybe we are getting closer to God. When the nights are long and we cannot sleep, trust that God is there, sitting awake with us. When we lose our sight, most assuredly God is there to fill our other senses. When depression weighs us down with a sense of darkness, most definitely God gently holds us. For those of you with darker skin who have been oppressed and shamed precisely because of your "darkness," know that you are made in God's image, beautiful and right.

So as we wait through this Advent season, let us reconsider darkness. God does dwell in light too, yes, and hope is often symbolized as light. But there is nothing that God created that isn't inherently good and no place where God is absent. We can trust that God dwells in the darkness. Thanks be to God.

EXECUTIVE BOARD MINUTES First Congregational United Church of Christ – Grand Ledge Executive Board Meeting Minutes October 25, 2022

Call to Order:

Moderator, Leah Horn, called the meeting to order at 6:30 p.m.

Board Members present were: Charlene Avery, Gary Cypher, Kim Dible-Glasser, Ron Erskine, Lynn Hart, Karen Holcomb-Merrill, Leah Horn, Pastor Laura Miller-Purrenhage, Thea Oatman, Mary Lou Prevost and Kelly Stuible-Clark.

Excused Members:, Fay Schroeder

We began with the planned non-triangulation training presented by Pastor Laura. Triangulation is when one person goes to another person about an issue they are having with a third person with the hope that the second person will resolve the issue for them.

Spiritual Reflection:

Leah began the meeting with a prayer from the Daily Devotions written by Pastor Vickie Kemper from Massachusetts, which was based on Psalm 121: 1-2.

Open Forum: Chuck Byam was here to listen and to show the LED colored string lights with remote, which he brought that could be used behind the cross to replace the neon light that was broken when the electric company was installing the cable for the mike. When the original fans that they ordered would not work for us, they went ahead and ordered different fans from another supplier which they hope to install tomorrow (Wednesday, October 26).

Bil Turner was also present to ask the Board direction for how we wish to proceed concerning the broken light. It was decided by the Board that ultimately, it would be the electric company's responsibility to replace the light. Bil will take care of this with the electric company tomorrow. Also noted, the company has ordered the replacement cable and mike which had been broken during installation.

Consent Agenda:

There were no board reports submitted.

Pastor Laura took on the job of resolving issues with the internet. Larry met with Comcast who stated that they believe the problem we are having is because the port used to connect the two computers to the ethernet is not working. To correct this problem, David Gruner suggested that we purchase a Netgear switch for the ethernet which costs \$20 to \$40. Comcast replaced the router in the hallway which they said was old even though it had just been replaced a year ago.

All consent reports were accepted as submitted.

EXECUTIVE BOARD MINUTES (CONT.)

Action and Discussion Items:

Update of Call Agreement Language Regarding Hours of Work:

Karen updated Pastor Laura's call agreement in accordance with the decision of the Board at the September meeting, to reflect the revised 25 hour work week to accommodate her new responsibility as Chief of Staff. At the same time, it was also decided to update the language which would replace the dollar amounts for salary and housing allowance, which requires updating her call agreement every year, to indicate "the amount at a rate which would be determined by the Executive Board and the congregation based on the current year's budget".

Possible Bystander Training February, 2023 - Tabled

This item will continue to be tabled until the November meeting for further discussion.

Updated Pastor Responsibilities Discussion:

This item has been tabled until the November meeting. All Executive Board members are asked to review the Ministries of the Church list prior to the meeting.

<u>Proposed Emergency Procedures:</u> With the decision to lock the back door during the service, it was decided that the Executive Board would keep that door locked during its meetings and enter by using the side door directly into the fellowship hall. The choir had the same concerns and decided that they would also keep the back door lock during rehearsals.

The Board decided that we should utilize the Accident/Incident Report Form as presented. It would be used in the event of any type of injury no matter how small or any accident or incident occurring on church property, regardless of whether they are a visitor, one of the congregation or a staff member. Forms should also be provided and explained to anyone filling out the building use form. Forms should be made available in the office and/or wherever it is deemed most accessible. Ron made the motion to accept and use the form whenever any accident, injury or incident occurs and make it accessible for anyone to use. Kelly seconded. Motion carried.

The Board reviewed the draft of the Active Violence Procedures, the current Emergency Plan which is posted throughout the building, and discussed other areas such as first aid kits, taking a video of all of the rooms and equipment, periodically review our insurance coverage, and exploring possible basic first aid training through the local fire department and/or Red Cross. Discussion centered around dissemination of information to the congregation, identifying individuals or staff who would be assigned tasks in the event of an emergency such as calling 911 or directing people to the exits. Mary Lou agreed to prepare a draft procedure which would be presented to the Board for input.

EXECUTIVE BOARD MINUTES (CONT.)

<u>Improve Webpage and Social Media Presence:</u> Pastor Laura discussed the availability of a Vitality Award Grant which is available through the Michigan Conference. This could be used to improve our current Webpage which, in turn, could impact our social media presence. Because it would require a great deal of preparation and time to complete the grant requirements, we decided it is not feasible to pursue this at this time since the filing deadline is November 15.

This item has been tabled until next year when we may have more preparation time. Meanwhile, Kelly posts once a week on our site, but is limited because she does not receive any content such as stories, pictures, projects and news from others in the church. It was suggested to reach out to the church boards for any input they may have.

Request to Reimburse Choir Director for Personal Payment Made to a Substitute Director: Pastor Laura, in a conversation with Brandon, learned that in 2019 when Brandon had to be away, he paid, out of pocket, \$75 for a replacement. After thoroughly discussing this concern, the Board concluded that this was never brought before them, and everyone felt this should be resolved even though it was 3 years ago. Motion was made by Karen to reimburse Brandon \$75. Seconded by Charlene. Motion carried.

<u>Job Description Revisions:</u> A discussion concerning job descriptions centered around the need for clarification for paid time available to staff. It is thought that there may be a formula used by the Treasurer and/or which may be found in the office files, for determining this payment. Once it is ascertained, this information will be added to each of the job descriptions.

Miscellaneous Updates:

<u>Services on December 25th:</u> Leah reported that David Wee is available to work that day to stream the service. Not enough chancel choir members nor bell choir members are available, nor is Chuck, but Brandon will provide pre-recorded music from the choir.

<u>Christmas Cantata during December 18 service:</u> Brandon had put together a proposal for costs for the instrumentalists and an extra \$500 for a pianist because Chuck is not comfortable playing for the cantata. The total cost would be \$1,550. Lynn mentioned to Brandon, that in the future if he plans this type of event, he would need to request additional funds in time to be included in the budget. Resources are currently available through various funds including money remaining for the Bell Director salary which we will not be spending. These funds will offset the accompanist line item which will be over budget.

<u>'Ceiling Fan Installation:</u> A motion was passed at the special Board meeting of October 11, 2022 to not proceed with the installation of the fans that are not compatible with our needs. However, since that action, R & M Electric Company has found compatible fans which they expect will work. Consequently, the Board agrees to move forward with the

installation of these latest fans providing they will actually meet our needs.

<u>Parking Lot Repair E-Mail Vote:</u> Thanks to Gary for his initiative, the repairs to the driveway entrance and the trenched portion, which was due to the electrical replacement for the sign, were completed effective October 20, 2022. The expenditure of \$850 to Grand Ledge Paving was approved via e-mail vote taken on October 19, 2022.

<u>Parking Lot Lighting Repair</u>: Thanks to Leah's husband who replaced the parking lot's double LED light which was out.

At this time, the Board went into a closed session to discuss personnel concerns.

The next Board meeting will be Tuesday, November 15, at 6:30 p.m. in the Fellowship Hall. Meeting adjourned at 9:10 p.m.
